# TEMPORARY TRIP PERMITS PURPOSE

*Temporary Trip Permits are required for all Motor Carriers who do not possess the proper credentials to travel outside the state of North Carolina.*

## INTRASTATE CARRIERS

- ✓ Required for *Out-of-State* Travel
- ✓ Trip Permit (*Tag*)
- ✓ Fuel Permit (*Decal*)

Services



## IFTA CARRIERS

- ✓ Revoked IFTA License
- ✓ *Out-of-State* Travel is required by IFTA Inc.
  - *NC Only Miles/ No Out-of-State Travel*
  - *Fuel Permit (Decal)*
- ✓ Require Temporary Decal Permit After Hours
  - *Fuel Permit (Decal)*

# TEMPORARY TRIP PERMITS **ISSUANCE**

- ✓ **Arrange your Travel Prior to Entering the State**
- ✓ **Issued by Jurisdiction and Permitting Services**
- ✓ **Temporary Trip Permit (*Tag*)**
  - *Additional Permits may apply.*
  - *Additional Fees may apply.*
- ✓ **Temporary Fuel Permit (*Decal*)**
- ✓ **Must Contact Jurisdictions Individually**

# PERMITS BY JURISDICTION

## TEMPORARY TRIP PRICING

Jurisdiction	Trip Permit \$	# of Days Valid	Fuel Permit \$	# of Days Valid
<i>South Carolina</i>	\$15.00	3 days	\$15.00	10 days
<i>Virginia</i>	\$54.50	10 days	\$59.50	10 days
<i>Georgia</i>	\$30.00	3 days	\$16.00	10 days
<i>Tennessee</i>	\$69.50	3 days	\$30.00	7 days

- ✓ Pricing for Permits vary by Jurisdiction
- ✓ Number of Days Valid vary by Jurisdiction
- ✓ Obtaining the Valid Credentials

# IFTA TEMPORARY DECAL PERMITS **REQUIREMENTS**

- ✓ **Licensed as an IFTA Motor Carrier**
- ✓ **IFTA Account must be in Total Compliance**
- ✓ **Operation in any IFTA Member Jurisdictions**
- ✓ **Copy of IFTA License**
