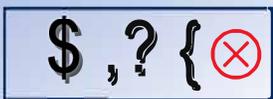
Guidelines

Do not select "print on both sides of paper."



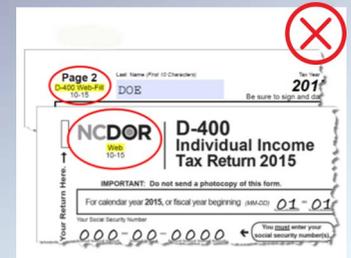


