Do not select "print on both sides of paper."



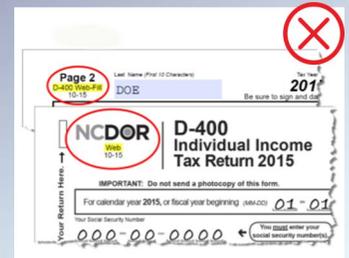
Before Sending
