


## In The Beginning

- 1939 to 1971 The Tax Supervisor
  - Machinery act was rewritten in 1971.
  - Qualified any Tax Supervisor holding the office on July 1, 1971.
  - Beginning July 1, 1973, the commissioners may only appoint a person certified by NCDOR that he has been "instructed." It requires the NCDOR to provide an instructional program.

  - Listing and Assessing
  - IAAO 101
  - Personal Property (IAAO or NCDOR)

  - USPAP 15-Hour 2015 addition
  - Voluntary

- 1983 NCAAO Professional Designation Program
  - NC Certified Real Property Appraiser
  - Member of NCAAO
  - 5 years in NC Assessors office, 3 years experience
  - Listing and Assessing
  - IAAO 101
  - IAAO 102
  - IAAO 300, 311, or 312
  - USPAP 15-Hour 2015 addition
  - Signed verification statement from supervisor
  - Voluntary







## The Beginning

- 1983 General Assembly House Bill 202
  - Certification and CE for Assessors and Appraisers
  - NCGS 105-289 NCDOR provides the program
  - NCGS 105-294 Assessors pass 4 courses and exam, 2yrs
  - NCGS 105-296 Appraisers, Listing and Assessing, exam
  - NCGS 105-299 Employees of appraisal firms, exam
  - NC Administrative Code specifies courses
  - Required! NCDOR website






