General Sovereign Ideology

Loosely organized collection of groups and individuals who believe the established government has no authority over them...

Organized: Groups of sovereign citizens conducting orchestrated acts of government disobedience

Independent: Individuals that learn the ideology from other people. They do not belong to a group and, as a result, are very difficult to identify.

Sovereigns In The News

Father and son Jerry and Joe Kane

On May 20, 2010 the Kanes are stopped in West Memphis, Arkansas for a fictitious registration plate

Jerry Kane distracts 2 interdiction officers with strange sovereign paperwork while 16-year old son ambushes officers with AK-47

Kanes flee the scene, leaving both officers dead and are soon located and engage in firefight with other officers



Sovereigns In The News

Wesley Snipes

Submitted fraudulent and fictitious federal tax claims to IRS from 1996 to 2005

After being indicted in 2006, Snipes asserted he was a “non-resident alien”, in effect claiming sovereignty from any tax laws

Served federal prison sentence in PA, 2010 (3 year sentence)



Sovereigns In The News

Andrew Joseph Stack

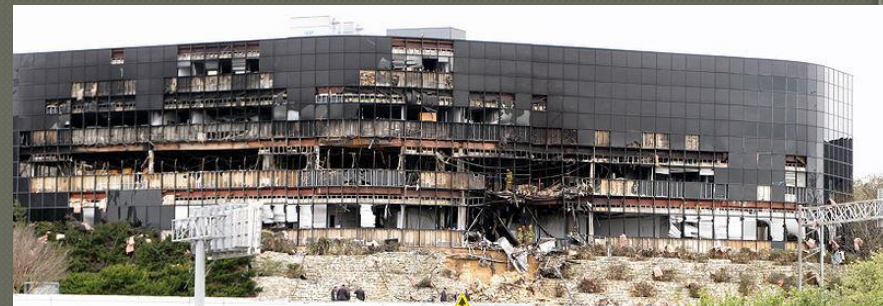
On February 18, 2010 Joe Stack flies his Piper Dakota into IRS building in Austin, Texas

Being audited for failing to report income

Posts suicide manifesto online the morning of the attack

Manifesto includes displeasure with the federal government and the IRS

Mentions the “Sovereignty” of individuals and their right to withhold taxes



Sovereigns In The News

Terry Nichols

Army friend and co-conspirator
with Timothy McVeigh

Described himself in district
court hearings in 1989 as a “non-
resident alien”, and attempted to
satisfy his credit card debts
through “Redemption” scheme

On April 19, 1995, McVeigh with
Nichols’ assistance killed 168
American citizens with the
bombing of the Alfred P. Murrah
Federal Building in OK City

Cliven Bundy, SE Nevada

April 2014

Bundy ranching family utilizing BLM lands to free-graze cattle

Federal government seized cattle, which led to an intense multi-day standoff at Bundy Ranch

Hundreds of militia, sovereigns, and conspiracy theorists flocked to support Bundy

*Multiple notary stamps

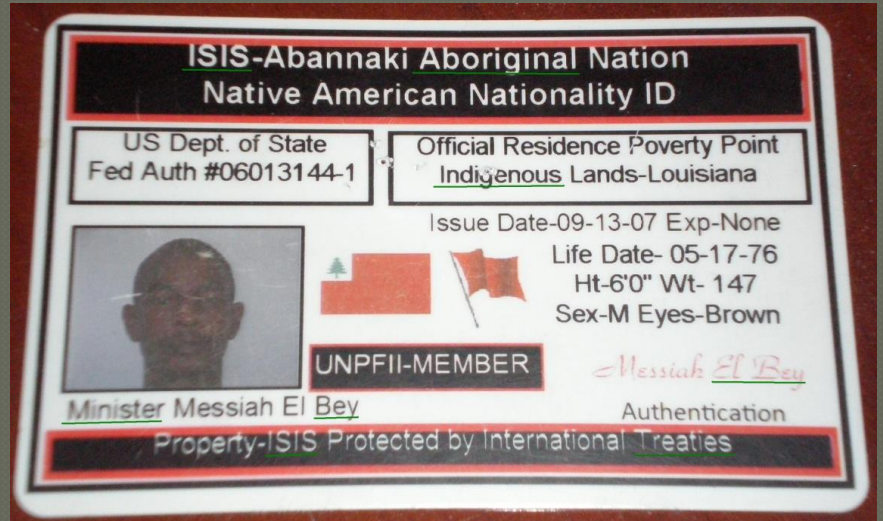
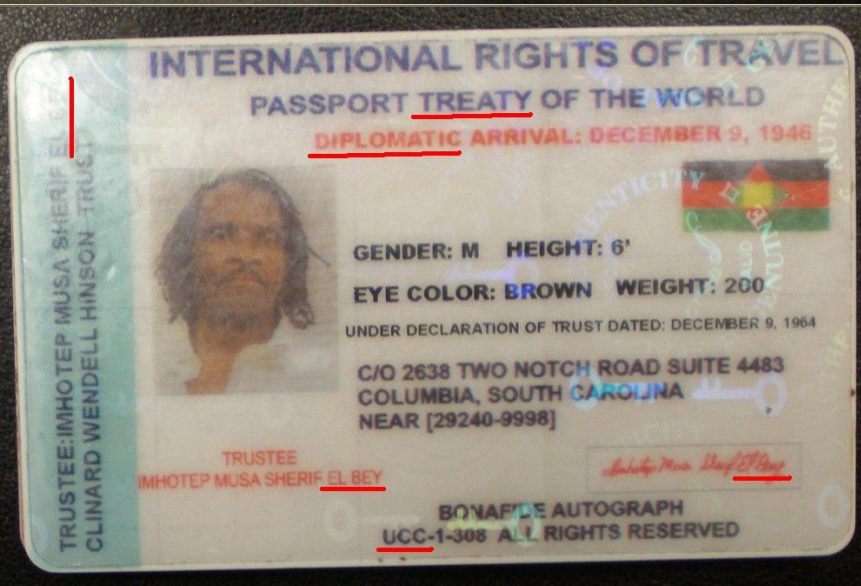

- **NCGS 14-118.6**
- **IT SHALL BE UNLAWFUL FOR ANY PERSON TO PRESENT FOR FILING IN A PUBLIC RECORD OR A PRIVATE RECORD GENERALLY AVAILABLE TO THE PUBLIC A FALSE LIEN OR ENCUMBRANCE AGAINST THE REAL OR PERSONAL PROPERTY OF A PUBLIC OFFICER OR PUBLIC EMPLOYEE ON ACCOUNT OF THE PERFORMANCE OF THE PUBLIC OFFICER OR PUBLIC EMPLOYEE'S OFFICIAL DUTIES, KNOWING OR HAVING REASON TO KNOW THAT THE LIEN OR ENCUMBRANCE IS FALSE OR CONTAINS A MATERIALLY FALSE, FICTITIOUS, OR FRAUDULENT STATEMENT OR REPRESENTATION. ANY PERSON WHO VIOLATES THIS SUBSECTION SHALL BE GUILTY OF A CLASS I FELONY.**
