




Instructions to Run the NCVTS "Exempt Report" (Select and Run the Report)

Click on the to "Admin" pull-down menu, and choose "Reports"




In the right hand corner of the screen, click on the pull-down list, select "NCVTS Exempt Report" and click "Go".





(Select Report Parameters)

After you've hit "Go", the screen with the report parameters will display.




For the 2019-20 AV-50 report due November 1, 2020, the following periods should be chosen:

Select Renewal Date Fiscal Year: "2019 - 2020"*

Select Abstract Year For: "2018, 2019, 2020" (click each)


Select Renewal Date Time Period: "Year" or run a separate report for each quarter "Q1", "Q2", "Q3" and "Q4" and total them (if NCVTS times-out when you run it for the entire year). Alternatively, reports can be run for single years ("2018, 2019, 2020").




Hint: Some users have indicated that the report is less likely to time-out if run outside normal business hours, after 5:00 PM.



Once the parameters are chosen, click the "View Report" button to the right.



The display should show that the report is loading:







The export button is in the top ribbon, below the report parameters.



To export the data into excel, Click on the export icon below, to display the report format, and click on the format you desire, "Excel" in this example.






Once the data has exported, you will receive the following notification to open or save the data:



You can save the output to your computer or open it. The resulting excel file will look just like the file displayed above.



The amount to be included on the AV50 form, line 17.5 "Excluded & Exempt Registered Motor Vehicles (NCVTS)" is the total after the last row of data, or the combined totals if you had to run multiple reports.



The total exempt value should be populated for the county only (not the municipalities) in the personal column as follows:
