## Form NC-3X File Layout Specifications

### Purpose of Document

The purpose of this document is to provide the file format instructions and guidance for the electronic filing of Form NC-3X.

### What's New

- Until further notice, the Secretary of Revenue will continue the automatic waiver of the penalty for failure to file Form NC-3 in the format prescribed by the Secretary.

### File Format Requirements

- **File Format** – The eNC3 application will only accept text (.txt) files; no other file format extensions will be accepted. Some examples of unacceptable formats include PDF's, MS Word and MS Excel.
- **Testing File Formats** – Prior to submitting your file, the eNC3 application will allow you to test your file layout and confirm if it's formatted correctly. This will ensure your file will be uploaded successfully without generating an error. - **Naming Convention for Uploaded Files** - In the root directory, the file name should be "NC3XRETURN.txt" For each NC-3X file that will be uploaded, the file name must be unique. If the NC-3X file requires multiple uploads within the same submission, name your files NC3XRETURN\_01.txt, NC3XRETURN\_02.txt, etc. This naming convention is a suggested format, however, if your system requires a different format which includes the date and time of the file, please ensure that the each file name includes the form type in the filename (i.e., NC3X100120181259.txt).

### Reminders

- State Withholding Account Number MUST be numeric; APPLIEDFOR is not a valid entry. Please reference the eNC3 [FAQ's](#) for information on how to obtain a withholding account number (if applicable).
- The eNC3 application will only allow current year 2020 and prior years 2019 & 2018 filings.
- Prior year data, original and corrected, must be filed according to these specifications. A separate submission is required for each tax year.
