SUBJECT: Local Government Sales and Use Tax Distribution

Attached is the collection and distribution report for the county Sales and Use Tax levies for the month ending August 31, 2008. The total distribution for the month is \$ 220,688,197.12. The cost of collecting the tax is \$ 0.403 per \$ 100.00 of collections, which is retained by the State.

Attached is the collection and distribution report for the local government Sales and Use Tax for public transportation for the month ending August 31, 2008. The total distribution for the month is \$ 5,784,382.70.

Attached is the collection and distribution report for the local government Sales and Use Tax for Beach Nourishment for the month ending August 31, 2008. The total distribution for the month is \$ 10,856.49.

Attached is the collection and distribution report for the additional local government Sales and Use Tax for Article 46 for the month ending August 31, 2008. The total distribution for the month to the eligible counties is \$ 983,805.08. The cost of collecting the tax is \$ 0.403 per \$ 100.00 of collections, which is retained by the State.
